

**Traylor Dixon Sells, Jr. Scholarship Application**

**The Traylor Dixon Sells, Jr. Scholarship** honors T.D. Sells, Jr., President of the Coastal Bend Community Foundation from 1988 to 2002. Mr. Sells was Coordinator of the Internship Program for the College of Business at Texas A&M University-Corpus Christi from 1989 to 2004. Formerly, Mr. Sells was President and CEO of Parkdale Bank of Corpus Christi and served as director for numerous non-profit organizations, and as President of the Corpus Christi Chamber of Commerce.

The one-year scholarship award is \$2,000 (\$1,000 per semester). Applicants must be graduate students in the Texas A & M – Corpus Christi College of Business Program. Recipients must take a minimum of 6 credits per semester while maintaining a 3.0 GPA.

**Guidelines and Instructions:**

To be considered for a Traylor Dixon Sells, Jr. Scholarship, an applicant must:

1. Be enrolled as a graduate student in the College of Business at Texas A & M – Corpus Christi;
2. Demonstrate leadership through extra-curricular and/or community service activities;
3. Enroll as a full-time graduate student (at least 6 semester credits) and maintain a GPA of 3.0 on a 4.0 point scale;
4. Submit the following in one envelope:
  - a. Completed application form;
  - b. Proof of acceptance/enrollment as a graduate student in the College of Business at Texas A&M University, Corpus Christi;
  - c. A sealed letter of recommendation from an instructor, advisor, administrator or work supervisor.
