Technical Training Scholarship Application**

**APPLICATION DEADLINE August 23, 2013**

**Award:**

- Scholarships are awarded to students enrolled or accepted into certificate programs in a technical or vocational field that leads directly to the workforce. Technical or vocational training is defined as training that does not lead to a Bachelor's or Associate's degree
- Students may enroll in eligible programs at Coastal Bend College (CBC), Craft Training Center (CTC) or Del Mar College (DMC). Up to \$1,000 per term will be granted for approximately 50 students for terms beginning Fall 2013. Awards are paid directly to the institution and may be used for tuition, fees, textbooks and course supplies
- Scholarships will be eligible for renewal for one additional term, Spring 2014, if student passes previous term with a C (2 point on a 4 point scale) or better and maintains at least 6 credit hours

**Eligibility:**

- Residents of the seven counties served by the Coastal Bend Community Foundation – Aransas, Bee, Jim Wells, Kleberg, Nueces, Refugio and San Patricio and meet residency requirement of CBC, CTC or DMC.
- Currently employed – provide proof of current employment. Need not be in technical or vocational field
- Demonstrate financial need through 2012 IRS Form 1040 or other means acceptable to educational institution
- Student is enrolled or accepted into a qualifying program
- Enrolled for at least 6 credit/contact hours per term

**In order to be considered for this scholarship, please submit the following:**

- The completed application form
- Written statement of goals/interests and the significance of this award to the applicant (no more than 2 pages)
- Letter of recommendation from employer, instructor, etc.\*
- Copy of the first 2 pages of the most current completed IRS Form 1040 or the first page of IRS form 1040EZ or other means acceptable to educational institution
- Proof of residency in any of the seven counties listed above
- Proof of employment
